# CMI Annual Membership Meeting November 12, 2019 7:00 pm Messiah Methodist Church 17805 County Rd 6, Plymouth, MN 55447

Our next meeting is the annual membership meeting. We will start with a vote to approve the new Bylaws update followed by officer elections. The membership meeting will then follow. Nominations will be open until the ballots are handed out.

### **Bylaws November Update**

A few updates have been made to the bylaws since they were distributed in the October Leeky Seel. This is a summary of the changes.

Several people reported typographical errors. All that were reported have been corrected. A member expressed confusion over the apparent contradiction between having the dues rate set in the bylaws and having them set by the directors. The troublesome statement was: "Club dues shall be \$20.00/year and may be adjusted as needed by the directors." It has been changed to: "Club dues shall be set by the directors."

The \$20 reference was to set a starting point. Since the club is currently operating under a set of bylaws these are actually an amendment. So, the \$20 starting point isn't needed. Scanning the rest of the bylaws for similar references identified some simplification of the amendment process. Concern was expressed that dues "are due in January and will be delinquent at the first regular meeting each year" left little time to follow up with non-payers. Thus, "first" has been changed to "second" to allow some follow-up time.

Concern was expressed that the reference "as specified by state law" wasn't specific enough. It has been changed to "as specified by the Minnesota Nonprofit Corporation Act".

A member expressed confusion over election of directors. He was unsure whether elections would simply choose 5 directors or select individuals for specific officer positions. Consequently, all references to "directors" in the elections article have been changed to "officers". The rest of the bylaws have been adjusted to correspond.

Concern was expressed that there was no provision for removing a director, should the need arise. A section has been added that addresses abandonment of office and allows the directors to fill the office that has been abandoned.

# **Donate to Home Free Shelter**

Home Free located in Plymouth, MN, is a safe haven for women and children who have needed to flee their homes due to domestic violence. The Shelter provides emergency housing and support services to over 600 women and children each year. Usually filled to capacity, the Shelter can accommodate 30 women and children with an average length of stay of 18 days. Services are provided free of charge to all residents.

# **Changing lug bolts**

Let's say you wanted to change out your lug bolts. Maybe because they are stretched or maybe they are beat up because you forgot to fully tighten them and then the wheel started to wobble or maybe they were too short for your latest modification (such as a five bolt flange behind a four bolt flange) or whatever! The question is: how do you get the old guys off? I thought about using a BIG hammer but I also thought about the wheel bearings and the bearings in the Differential that would all take the brunt of that BIG hammer. Not a good plan.





Here's a neat tool that Gary gave to me. It really did the trick. It's a ball joint tool that might work if you could get

it positioned the right way – a lot like all the other ball joint tools, some work better than others.

It turns out that this guy works very well on this type of a job. It has a two-finger shape on one side and a middle finger shape to oppose the two but not over here where you are wrenching. When it is positioned to remove a lug bolt the front

finger is mounted against the nut-end of the bolt and the back side of the tool is used to push against the flange in which the lug bolt is swaged. Let's see if we can show this.




Here we see two fingers behind the flange. The force applied by the Ball-joint tool's screw will bring these two towards the single finger.

Here's Mr. singleton with his business end right on the nutend of the stud/bolt. In a sideview, of course.

As the Tool's screw is advanced, the bolt and the flange are in opposition. Not like a pliers, more like a teeter-tooter. As you



turn the ¾" socket, or maybe it was 19 mm, that massive pivot swings into action and the bolt resists for a click or two but then it begins to move into the flange. Once the splines of the bolt are clear – out of





The nice thing about this tool is that you can adjust the pivot position, to make it work in closer quarters. Above/left we see the tool in the "closer" configuration, so I could push the new stud all the way back into the flange. Sort of like shifting gears, with a long reach for removal and then the shorter reach for installation.

If you want a tool like this, I think they cost ~\$15 at Harbor Freight. New lug bolts are a couple bucks apiece and the nuts aren't cheap either.

BUT, well worth it!

Let's keep on CORVAIRing, shall we? Fran

Many of us remember the horror of filling the dumpsters with Egil Twedt's good Corvair stuff.

I get calls all the time with Corvair stuff for sale. It's increasingly hard to find the room, money and time. Should I scrap Don Schaefer's '61 80 HP so I have room to put another 140? To what end since I never seem to have time to use it anyway? I know it's hard to say "no thank you" once I get there, I get in a rescue state of mind, it's the same thing with kittens. I'm sorry to say that I have a lot of stuff stored outside for lack for room. The best shrouding is the oily stuff, it's like Jeeps with cosmoline. It seems like Corvair stuff isn't worth much these days until someone needs something. Every year big collections are hitting the scrap piles even though scrap prices are low too. Do I have enough life left to realize an escalation in value? Yeah maybe, but what about if I just drop dead?

On "American Pickers" I see whole warehouses full of crap that people have left behind and think to myself "maybe I'm not so bad after all" but somehow it doesn't feel like a moment of clarity. I'm not giving stuff away yet either, sort of a tortured soul in limbo. How you doing?
